## **FINAL MINUTES**

### **I. Opening of Meeting/Roll Call**

The meeting was called to order at 1:02 PM. - A. Approval of the May 18 GSP Coordination Committee Meeting Minutes – *Action Item*

B. GSA Status Updates – *Round Robin Discussion*

1. Current Groundwater Conditions, Projects and Management Actions, Funding, and General Updates
  - i. City of Lathrop – The City's ASR well project was approved for funding through DWR's Urban and Multi Benefit Drought Relief Grant Program with total project funding equaling \$4.5M in grant funds and \$1.5M in local cost share.
  - ii. City of Tracy – Nothing to report.
  - iii. BBID – The District is working on getting up to speed with its data collection relevant to groundwater sampling. It was noted that domestic and static wells in the area are difficult to measure for a number of reasons, and thus, the District is hoping to eliminate those types of wells from their data collection in the future. Otherwise, the District is largely focused on irrigation efforts at the moment.
  - iv. San Joaquin County – The County adopted their budget for the next fiscal year. The County is still looking to integrate the data management systems for the Tracy and Eastern San Joaquin Subbasins in order to optimize the collection and reporting of data. Additionally, the Corral Hollow Pit Project is still a topic of discussion. The County is conducting scoping efforts for the projects and discussing its potential with interested parties. The project is believed to have substantial long-term water supply

benefits. As such, the County is planning to review funding opportunities to help progress the project.

- v. Stewart Tract – Nothing to report.
- vi. BCID – The District was recently awarded \$10M out of the \$14M needed to implement their Pipeline Extension Project through Sustainable Groundwater Management Round 2 Funding.

#### C. GSP Implementation Updates

##### 1. FY 23/24 Budget – *Action Item*

- i. Mr. Shatz reviewed the finalized budget and GEI's work proposal for the next fiscal year inclusive of comments and edits requested by the GSAs in previous Committee meetings. In order to develop the budget, Mr. Shatz averaged the total costs over three of years so that the final budget would be consistent from year to year. Some of Mr. Shatz notes while reviewing the budget with the GSAs included: GEI was now fulfilling some of the relevant regulatory requirements in house, which reduced costs to the GSAs; there were two dry wells within the Subbasin that were mitigated by fixing issues with the wells' pumps; and there has been no determination made on the Tracy GSP as of yet, but the level of effort was unknown at this time should the GSAs need to conduct additional work on the GSP. Additionally, Mr. Young requested clarity on how the shares of the Zone 2 funds were calculated. Mr. Shatz stated that he believed it was weighted but would need to double check. Mr. Young replied that going forward, he believed the Zone 2 contributions should be determined by groundwater pumping rather than acreage, but that was a conversation needing to be had separately from the current one. The GSAs voted unanimously to approve the budget and GEI's proposal, which were noted in detail within the PowerPoint presentation included in the meeting packet.

##### 2. TSS Update – *Discussion Item*

- i. Mr. Shatz explained DWR's process for funding TSS efforts did not include an actual exchange of money. DWR would, instead,

be directly funding the work and the Subbasin would be receiving well drilling services costing approximately \$1M.

3. Groundwater Conditions – *Discussion Item*

4. AEM Surveys – *Discussion Item*

- i. The Airborne Electromagnetic Survey datasets for the Tracy region are currently available in the California Natural Resources Agency Open Data Portal.
